## **DECISION**

# on the functions, tasks and organizational structure of the Vietnam Investment Review

#### MINISTER OF PLANNING AND INVESTMENT

*Pursuant to the Press Law dated April* 05<sup>th</sup>, 2016;

Pursuant to the Decree No. 89/2022/ND-CP dated October 28<sup>th</sup>, 2022 by the Government stipulating the functions, tasks, powers and organizational structure of Ministry of Planning and Investment;

Pursuant to the License for print and electronic newspapers operation No. 541/GP-BTTTT dated August 23<sup>rd</sup>, 2021 by the Ministry of Information and Communications;

At the recommendation of the Editor-in-Chief of the Vietnam Investment Review and Director General of Department of Organization and Personnel.

#### **DECIDES:**

#### **Article 1. Position and functions**

The Vietnam Investment Review is the press agency of Ministry of Planning and Investment, performing the function of information and propaganda about laws, policies and the implementation of tasks of economic, cultural, social development, investment, business and tourism activities of Vietnam in accordance with the provisions of the Press Law, State laws and the direction of the Minister of Planning and Investment.

The Vietnam Investment Review is a public non-business unit that covers its own regular expenses, has its own seal and account, and operates autonomously in accordance with the law and the management decentralization of the Ministry of Planning and Investment.

#### Article 2. Tasks and powers

- 1. Informing and propagating to domestic and foreign organizations and individuals of all economic sectors the guidelines and policies of the Party and State, and Vietnamese legal regulations on investment, business, cultural and social environment; the tasks and activities of Ministry of Planning and Investment.
- 2. Informing on domestic and international situations for research and policy planning for national socio-economic development, sectoral economics, market research, consultation and decision-making on investment, business and tourism, contributing to mobilizing domestic and foreign resources for development investment.

- 3. Reflecting the country's orientation, achievements, and lessons learned about investment in socio-economic development, setting good examples and new factors, fighting against law violations and negative phenomena in the socio-economic field.
- 4. Introducing foreign policies, laws and experiences in socio-economic management serving cooperation, development and integration.
- 5. Managing the organizational structure, public employees and workers of the Vietnam Investment Review and its finance, assets and funding according to the provisions of law and the management decentralization of the Ministry of Planning and Investment.
- 6. Implementing information and reporting regimes according to regulations of the Ministry and other tasks assigned by the Minister of Planning and Investment.
- 7. Carrying out business and service activities of a press agency according to the provisions of law.
  - 8. Carrying out social charity activities.

#### Article 3. Organizational structure

- 1. Office;

- 7. Issuing and Sales Division;
- 8. Accounting and Finance Division;
- 9. Representative office of the Vietnam Investment Review in Ho Chi Minh City;
- 10. Representative office of the Vietnam Investment Review in the Central and Central Highlands regions;
  - 11. Representative office of the Vietnam Investment Review in in Hai Phong City.

The number of employees and number of contract workers of the Vietnam Investment Review is decided by the Editor-in-Chief.

### Article 4. Leadership of the Vietnam Investment Review

- 1. Leaders of the Vietnam Investment Review include one Editor-in-Chief and some Deputy Editors-in-Chief. The Vietnam Investment Review also has an Editorial Board Member.
- 2. The Editor-in-Chief, Deputy Editors-in-Chief and Editorial Board Member are appointed, dismissed and terminated by the Minister according to the provisions of law.

- 3. The Editor-in-Chief of the Vietnam Investment Review regulates the functions and tasks of the units under the Vietnam Investment Review, and develop working regulations and internal spending regulations of the Vietnam Investment Review in accordance with current law.
- 4. The Editor-in-Chief of the Vietnam Investment Review is responsible before the Minister and the law for all activities of the Vietnam Investment Review.
- 5. Deputy Editor-in-Chief and Editorial Board Member of the Vietnam Investment Review are responsible to the Editor-in-Chief of the Vietnam Investment Review and before the law for the assigned fields of work.

#### **Article 5. Enforcement**

This Decision has come into force since the date of signing. Previous regulations contrary to this Decision are all annulled.

#### **Article 6. Implementation responsibility**

Director General of Department of Organization and Personnel, Chief of the Ministry Office, Editor-in-Chief of the Vietnam Investment Review and the heads of units and organizations under the Ministry are responsible for implementing this Decision./.
